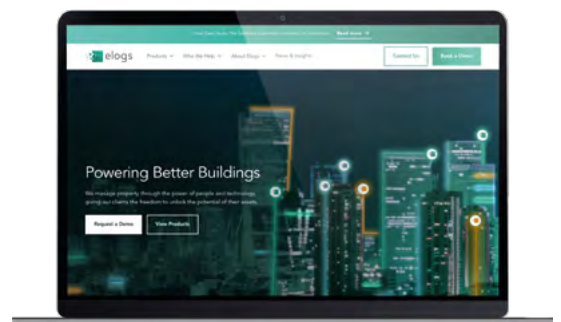

# What changes have we made?



Regarding the Elogs CAFM and Prosure360 integration, we have made several improvements, including:

- Expanded details of the reasons for the contractor's status to give more insight to users.
- Recording and sharing the Service Providers Prosure360 status at the point of job allocation and completion.
- Ordering Service Providers by their Prosure360 status to prompt usage of 'Verified' suppliers.
- Enhancing the presentation of Prosure360 contractor information within Elogs CAFM.
- Improved visibility and audit trails of user selections.
